

BEFORE REQUESTING PERSONAL DATA

Do you wish to request the non-public contact details of a domain name holder for legal reasons?

In most cases, these details can be consulted via the search function ([homepage dnsbelgium.be](https://www.dnsbelgium.be)), unless they have been hidden by the domain name holder.

This request form is intended exclusively for specific lawful and legitimate purposes. **Please verify whether your situation requires a request for personal data.**

What can this request NOT be used for?

- Verifying the details of a domain name holder as part of the verification procedure for newly registered domain names
- Contacting a domain name holder for commercial purposes
- Reporting a domain name that is not working
- Requesting a domain name transfer
- Requesting a new verification email ([link to verification email](#))

Use this form ONLY if:

- You have a legal reason to obtain the non-public contact details of a domain name holder
- You are involved in a legal dispute
- You require the details to enforce intellectual property rights
- You are acting on behalf of a government authority or law enforcement agency
- You can submit a sufficiently justified request with supporting documents

Important notice

Irrelevant or incomplete requests will be refused and may delay the processing of legitimate requests.
